- 3. HVAC Mini Split Bid pricing shall include entire design and installation, as well as thermostat installation to control comfort levels.
- 4. Contractor and employees shall be trained and skilled to perform all related services, and have experience with all types of interior/exterior paint materials and all work shall be performed per manufacturer's recommendation.
- 5. Contractor shall be responsible for entire design, permitting, electrical and installation.
- 6. Installation dates will be determined upon selection of contractor.
- 7. Contractor provided materials for on-going maintenance (not the mini split system) will be marked up at an agreed upon percentage rate above wholesale, per contract. All invoices shall be required to include wholesale cost.
